Limitations of the method

The results obtained must always be interpreted in combination with the complete clinical picture and dietary changes must be made in consultation with a relevant dietician or nutritional expert. The IgG levels determined by using this test system make it possible to infer information about the degree of sensitization of the patient to the food antigens or mixtures tested. They cannot be used to derive a relationship between the determined IgG concentration and occurrence of serious clinical symptoms. False positive test results may be produced by cross-reactivity of the antigens being tested with the epitopes of other antigens.

Certain allergy associations do not support IgG testing as a means to diagnose food hypersensitivities. However, a growing number of publications and a large amount of anecdotal evidence support that elimination diets based on circulating IgG antibodies result in improved symptoms in patient. Informed consent for testing

ImuPro sample collection and transportation to MDS Laboratory

- **No payment for the ImuPro test is to be made to, or collected by, the laboratory/facility taking the ImuPro sample – clients will pay MDS directly for the test.**
- 2 – 4 hour fast prior to sample collection.
- A 5ml serum sample (Gel/SST Plain tube) of blood is required for this test and the sample sent to the MDS laboratory for analysis.
- Once the blood sample has been collected please ensure that the client's name and date of birth is written on the tube.
- Please place the blood sample into a sample collection bag with the completed Food IgG Test Requisition Form.
- Samples collected at Ampath Laboratory (in KZN) will be sent to Ampath's Sendaway department after which MDS will receive the sample.
- For samples collected at other private facilities, place the sample in the fridge and contact us to arrange courier to collect the sample.
- Blood samples should be couriered to MDS laboratory within 3 to 7 days at room temperature.
- MDS will process the sample within 10 to 14 working days of receiving the sample and payment.

Please note that the health practitioner/phlebotomist taking the blood sample must safely discard used needles. Under no circumstance must a used needle be returned to MDS with the blood sample.
